### Collate

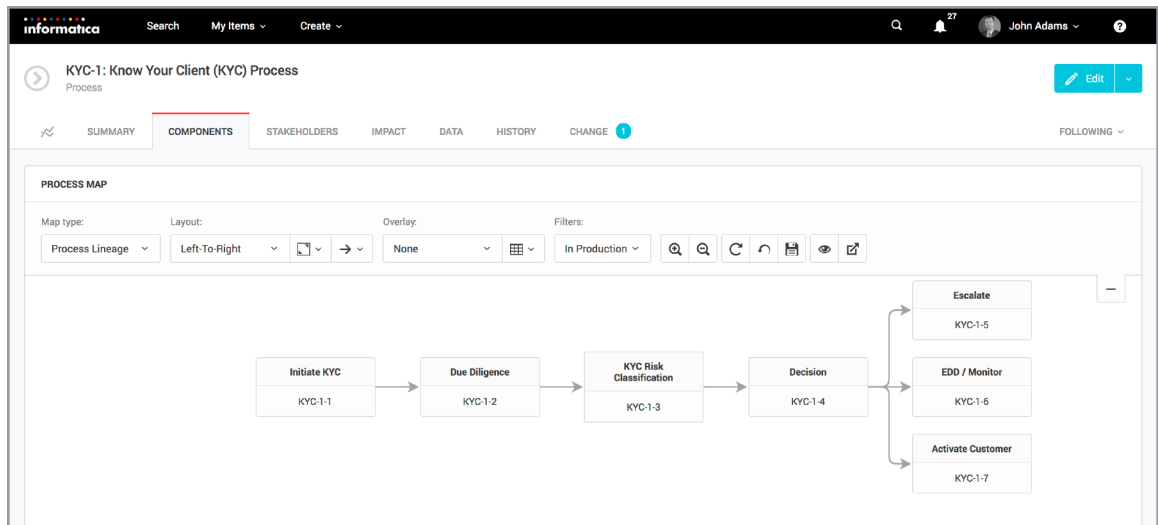

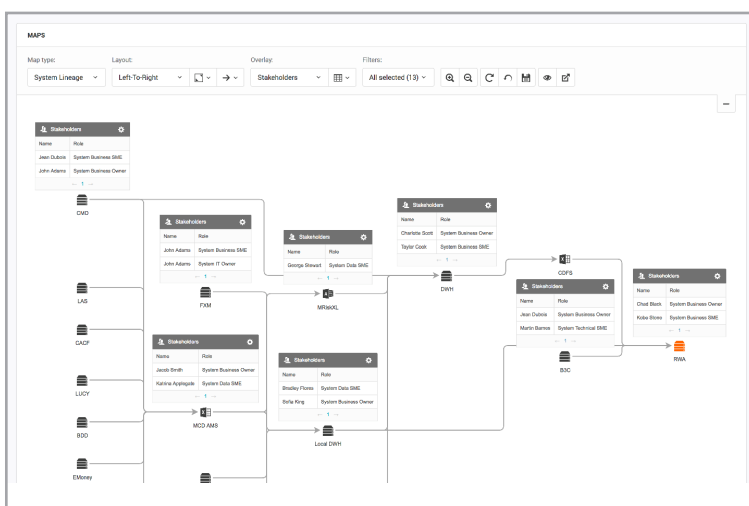
### Measure
